What is the out-of-pocket limit for this plan?	In- <u>Network</u> : Individual \$9,400 / Family \$18,800.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. Does this plan provide Minimum Essential Coverage? Yes.
